Note:-

- 1. Private candidates are required to submit their forms completed in all respects, alongwith the requisite copies of the certificates, degrees, DMCs, National Identity Cards, domicile and original migration certificate with **FOUR** latest Passport size photographs (**both male and female**) duly attested by a Gazetted officer.
- MA Final candidate having compartment in Previous are required to submit separate forms each for Previous and Final.
 Examination fee should be deposited in United Bank Limited (UBL) and HBL Lakki Marwat Branch. Fee remitted through cheques, Money/ Postal Orders will not be accepted. Partial payment of fees is not admissible.
- 4. Claim of any candidate to have sent examination admission form by post but not received at the office of the Controller of examinations, will not be entertained by the University, but the candidate will be responsible to settle it with the Postal Authorities.
- 5. Candidates having passed BA/BSc or equivalent Exam in Supplementary 2019 are not eligible for MA Part-I, as well as having passed BA/BSc or equivalent Exam in Supplementary 2018 are not eligible for MA Combined Annual Exam 2020.
- 6. The Examination Centers will be allotted to private candidates on the basis of their respective permanent home addresses as mentioned in the examination admission forms. However, the University reserves the right to allot any other examination center keeping in view the number of candidates and law & order situation in the area. A candidate, who wants to be examined in a place other than his permanent address, must provide proof his/ her/ parents/ spouse present address and service certificate etc with the form, duly attested by a Gazetted officer.
- 7. Two-year period after passing of the most recent examination is required for M.A combined examination.
- 8. All kinds of Cheating material, Electronic devices/ weapons are strictly prohibited in the examination Hall, which can lead to the cancellation of papers/ examinations.
