Terms / Conditions:

- 1. Any bid without 2% earnest money of the total amount will not be entertained.
- 2. Conditional/incomplete/overwritten bid will not be entertained.
- 3. The prices quoted must be valid for at least 90 days from the date of tender opening for the evaluation of tender.
- 4. The successful bidders will be required to supply the items as per KPPRA rules,
- 5. Telephonic/telexed/faxed/telegraphic quotations will not be entertained.
- 6. Firm Registration Certificate with the Federal/Provincial Government.
- 7. National Tax Number
- 8. Sales Tax Registration Certificate.
- 9. Bidder will provide an undertaking on judicial stamp paper of Rs.100/- that the firm has never been blacklisted currently or in the past by any Government/ Semi Government Organization. (Stamp paper will be verified by the university).
- 10. Dealership Certificate may be attached (where required).
- 11. The bidder shall indicate in his offer, list of items with prescribed specifications, the unit price and total bid prices of the items. Taxes levied by the Government, if any, shall be recoverable from the bidder as per rules.
- 12. The Price should be quoted in Pakistani Rupees.
- 13. The companies / firms are directed to quote their price including supply, transportation, and complete in working condition as well as including all government deductible taxes for which they will be held responsible.
- 14. Item will be supplied strictly according to the specifications given in the Tender Document and as per sample where required.
- 15. The suppliers are directed to quote the prices according to the specifications including all taxes given in the tender document. However extra sheet can be attached if required.
- 16. Rate of substandard item will not be accepted.
- 17. All bids must be properly sealed and delivered through mail/Courier Service before or on the given time and date and no personal delivery will be accepted.
- 18. All the relevant information's can be obtained from the office of the undersigned.
- 19. The supply should be made within the period, which the suppliers will clearly indicate in their quotation and must be strictly according to our requirements. In case of any delay

- 21. Call Deposit will be released after completion of satisfactory supplies.
- 22. An Agreement between the Successful Bidders / Supplier's and the Registrar, ULM will be signed on Judicial Stamp Paper of Rs.100/- before award of the contract.
- 23. The Tenders / Quotations without 02% earnest money / Call deposit or incomplete / unsigned documents will be summarily rejected.
- 24. Per unit rate of the items will be quoted strictly on tender document issued by the undersigned.
- 25. In case of any dispute (if), the decision of the University Purchase Committee, ULM shall be final and binding on both parties.
- 26. Specification/Sample along with price will be provided by the supplier.
- 27. The Competent Authority has the right to reject any or all the tenders clarifying reason for rejection.
- 28. Bid in sealed envelopes must reach to office of the undersigned by 01:00 PM on 13-07-2020 through registered courier service and will be opened in the presence of the contesting firms/their authorized representatives on the same day at 01:30 PM in the Committee room of University of Lakki Marwat.
