INVITATION OF BIDS

DESIGN/SOLARIZATION FOR EXISTING BUILDINGS AT UNIVERSITY OF LAKKI MARWAT

- University of Lakki Marwat, Lakki Marwat invites sealed bids from reputed firms/constructors for "Design/Solarization for existing buildings at university of Lakki Marwat " having adequate experience in carrying out projects of similar nature, valid registration with PEC in minimum Category C-6 with relevant field of specialization (EE04,EE11 etc) for year 2022-2023, valid Income Tax & Sales Tax registration and who are on Active Tax Payers' List at the time of Submission of Bids.
- The bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) which is mandatory under Finance Act 2013, Act No. XXI of 213 for works, therefore, photocopy of the revenue registration of bidders with revenue department as desired under the rules must be enclosed.
- Bidders may obtain the Bidding Documents from the office of Deputy Director P&D, University of Lakki Marwat or download from the university official website www.ulm.edu.pk, till 14th November 2022 during office hours (08:00 am -04:00 pm) upon payment of non-refundable printing fee of Rs. 2,000/- in shape of CDR/ Bank draft in favor of Treasurer, University of Lakki Marwat, Lakki Marwat. (Cash not acceptable).
Note: Bidders who choose to download Bidding Documents from University Official website will have to submit the Rs 2000/- fee with submission.
- Under Single Stage – Two Envelope Bidding Procedure, One envelope containing technical information of Bid shall be clearly marked 'Technical Bid' and the second envelope containing the price bid shall be clearly marked 'Financial Bid'.
- Pre-bid meeting will be held on 4th of November 2022 at 11:00 AM in Committee Room, University of Lakki Marwat.
- The envelop shall be accompanied by Bid Security in the amount of minimum of 2% of Estimated Price without indicating the figure in the letter, and in the form of Deposit at Call or Bank Guarantee issued by a scheduled bank in Pakistan in favour of Treasurer, University of Lakki Marwat, Lakki Marwat. The Bidder shall provide an affidavit along with Bid stating that requisite Bid Security is sealed with the financial bid.
- The bidder quoting their bid more than 10% below on Engineer's Estimate shall submit an Additional Bid Security according to latest KPPRA rules (Reference Khyber Pakhtukhwa Public Procurement Regulation vide Notification No. S.R.O. (14)/Vol:1-24/2021-22)
- Envelopes (Technical + Financial) shall be submitted to the address mentioned below by 14th November 2022 till 11:30 AM. The Technical Bid shall be opened on the same day at 12:00 PM in the presence of Bidders or their representatives who choose to be present. Bids received after the prescribed time and date shall be rejected.
- Bidders will be Qualified on the basis of information provided with the Bids, as per the Criteria prescribed in the Bidding Documents.
- University of Lakki Marwat, Lakki Marwat, however reserves the right to reject all bids at any time prior to acceptance of a bid as per Clause 47 of the KPK Procurement Rules, 2014 and grounds of rejection will be conveyed to the bidders upon their request.
- The bidder/firm will have to provide the following requirements at the time of receiving tender documents:
 - CNIC Copy
 - Pakistan Engineering Council registration
 - Tender documents printing fee (Non-Refundable) pay order or bank draft in favor of Treasure ULM
 - Written request on bidder letter head for issuance of tender/bidding documents.
